As you are aware Hugh Dickson and I were appointed as the joint liquidators ("JLs") of the Bank by Order of the Eastern Caribbean Supreme Court of Antigua on 12 May 2011. Our appointment as JLs of the Bank supersedes the appointment of the former joint liquidators, Nigel Hamilton-Smith and Peter Wastell on 15 April 2009. Following our appointment we have been working with our advisors to recover assets and to develop a business plan and budget to generate the maximum possible return to the Bank's creditors. As yet we have no money to distribute, however, in preparation for a distribution we are accepting and approving claims.
